Duane Long informed the Board of Commissioners that as of June we have used about \$20,000 of the promissory note. Anthony Venier asked when the note would be paid off. Duane Long reported in November of 2024.

VII. REPORTS

A. Commissioners-

- 1. Autumn Brady-Autumn said her son had his birthday party at the facility and she was very impressed from start to finish. SHe is concerned that we have not received many applicants for the new scholarship[program she and Jana Halfacre have been working on. They have promoted the program a lot and still no applicants. She is thankful for Tyler Hodapp in his quick response to cleaning up graffiti at Haymarket Square when she reported it to him.
- 2. Rodney Frey-Rodney reported the reason for him and Keith doing the park tour was in response to a community member that asked them to look at EC Smith Park. Rodney and Keith did trail maintenance on Fathers' Day. Rodney asked who was to mow the maintenance entrance to the bike trails. It had been Tyler and the bike club at different times. Anthony Venier said he will talk to the bike club about the trail cleanup.
- 3. Keith Aurand-Keith thanked all the staff for putting in hard work during the busy season. He was at the canoe launch on the day the opening was postponed and he saw

three people rent from our new kayak system. Keith asked the board if there could be a discussion at the next board meeting on a 5-10 year plan on upgrading the bike path. Keith also toured a couple parks with Rodney Frey and asked if some things can be done. EC Smith Park has a fence that appears to serve no purpose. Duane Long said the fence was installed to mimic the original fence when the park was named Kiddie Corral. The fence is used by parents to limit kids from running in the street. Keith said the tennis court at EC Smith is not playable at times when the sun is beating down and buckling the surface. He asked if something could be done to replace the surface. Duane Long said it may be more beneficial to create something other than just 3 tennis courts on that surface. He will look into it.

- 4. Anthony Venier-Anthony gave kudos to Tyler Hodapp for pouting in bases and soccer nets at Grace Johnston Park. He is also excited about the Page Drive improvements we will see with the City's grant.
- 5. Nathan McCoy-Nate received a compliment from the community on the clean bathrooms at Wooden Wonderland. Nate asked about possible lighting on our new signs in the parks. Duane Long will look into this.
- B. **Executive Director-**Duane Long updated the Board on the completion of the batting cages at Reynolds Field. The new sunshades at Pickleball were purchased by the Garden Club and they are not complete. The landscaping will be completed soon around the new sunshades. The railing at the Canoe Launch is complete and the grant inspectors will be here Thursday to approve the project. Vaile Park Basketball Courts are under renovation with the OSLAD Grant.
