The project cost estimate is \$10,000 for all the repairs and the City of Dixon will cover one half of the costs. Tyler's crew is pouring new sidewalks at John Dixon Park. He asked the board to stop by the Emma Hubbs Tennis Courts and see the courts have been pressure washed and the blacktop under the shelter has been resealed.
